

Scary Stat

Microsoft estimates that SMBs who use old PCs could **lose up to 7 days** per calendar year.

Now, naturally, Microsoft has some skin in the game and will benefit from people buying more computers. However, that doesn't mean the data in their report isn't accurate.

And that report says that computers that are more than 4 years old **cost 21 hours of productivity** due to repairs, maintenance, updates, and critical security fixes.

One good rule of thumb is if the cost required to maintain existing

hardware reaches 66% of the price of a new computer; you should opt for a new one.

Noisy fans, outdated security, trouble with multitasking, and lengthy startup and shutdown times are all signs it is time for a new computer.

- The optimal age of PCs is no older than 4 years, beyond which they are more expensive to maintain than replace.
- The total cost of owning a 4+ year old PC is \$2,736, enough to replace with two or more newer PCs.


